1. Assinatura cliente iha formulario hodi loke numero kontabilidade sei sai hanesan akordo official ho Banco Nacional de Comercio de Timor Leste (BNCTL), hodi hetan bilhete.  
*The client signature is an official aggrement with BNCTL to opening deposit account of getting the bilyet deposit.*
2. Bilhete ne'e rai didiak. Se karik lakon, Cliente tenke hato'o relatorio husi PNTL hodi bele bilhete duplikado tuir regulamento BNCTL nian.  
*Kept well the bilyet. Based on BNCTL rules the client have to submitted official statement by police to get the new bilyet if the bilyet was lost.*
3. Cheque / transfere cliente ne'ebe BNCTL simu liu husi prosesu kliring, bele sai hanesan balansu deposito ho prazu tuir akordo entre cliente no BNCTL.  
*The client check ou transfer which BNCTL receive by cliring process will be putting in time deposit balance based on aggrement between client and BNCTL.*
4. Pagamentu ba jurus depositu ho prazu sei transfere direitamente ba numero konta Deposito ho ordem/konta Giro. Foti osan so bele husi cliente rasik ou ema ne'ebe hetan autorisasaun no mos tenke lori bilhete cliente nian.  
*Payment for time deposit interest will transfer directly to passbook or check accounts. The owner is receive the fund or other people whose get authorization and also take the bilyet of the client.*

*If the client death, the balance is on the account number will proces ground on law and shall be paid to atuhority given based on the rule in the compentity Institution.*

*The time deposit will be extended automatically if there is no information by client to BNCTL.*
